COUNCIL AGREED to invest Parish Council POS Funds as follows: £125000 in The Hampshire Trust Bank 5 year fixed @4.65% approx £125000 in The Redwood Bank 2 year fixed @ 4.85% approx £75000 in The CCLA Public Sector Cash Fund @ 4.93% approx  Members considered the fact that the total amount with one bank exceeded £85,000 but COUNCIL AGREED that the risk of all 3 banks folding was minimal. It was farther agreed that £35000 from the Community Benefit Fund should also be invested in The CCLA Public Sector Cash Fund to maximise the interest on this also.
